Item #2A: Appointment to Fill Board Vacancy

#### **Background**:

Three Board seats, each a four-year term, were up for election on November 8, 2022. Chair Wipf and Vice Chair Horsley filed papers to run for reelection, and Director Bawcom did not run for reelection. No other District resident filed papers to run for the third seat. Since only two people filed to run for the three available Board positions, under Elections Code section 10515, those two were automatically appointed to the positions by the County. This resulted in the County Board of Supervisors appointing Chair Wipf and Vice Chair Horsley to another four-year term on October 4, 2022; and the November 8, 2022 District election was cancelled. The remaining third District Board seat for a four-year term became vacant on December 2, 2022, when the other Board members took office under the Uniform District Election Law.

State law provides that to fill the vacant seat, the District Board must, within 60 days from the commencement of the vacancy, or by January 31, 2023, either fill the vacancy by appointment or by calling a special election. At its December 14, 2022 meeting, the Board voted to fill the vacancy by appointment. The notice of the vacancy was posted at least 15 days before this meeting making the appointment.

#### **Discussion**:

The appointment method to fill a vacant District Board seat allows the Board to appoint a person to serve until the next general district election – i.e., November 5, 2024 (Gov. Code, § 1780(d)(2) ["[i]f the vacancy occurs in the first half of a term of office and at least 130 days prior to the next general district election, the person appointed to fill the vacancy shall hold office until the next general district election that is scheduled 130 or more days after the date the district board is notified of the vacancy, and thereafter until the person who is elected at that election to fill the vacancy has been qualified."]. Thus, at the November 2024 election, this seat would be up for election for a two-year term (i.e., the remainder of the four-year term for the seat). The person appointed to fill the vacant seat in the interim or any other person may seek election to the two-year seat. The Board position will resume its normal four-year cycle with the November 2026 election.

District staff posted the notice of vacancy and solicited applications for the vacant seat. As of the January 20, 2023 deadline to submit applications, the District has received one application. The applicant was notified and encouraged to participate in tonight's meeting. The Board can review the submitted application, hear a presentation or statement from the applicant, and appoint the applicant to the District Board.

Meeting Date: January 25, 2023

The criteria by which the Board chooses an appointee to fill a vacancy is at the Board's discretion. However, the deliberation, consideration and voting on an appointment to a vacant District Board seat must be done in an open session. The appointment can only be made by majority vote of the remaining Board members.

If appointed, the applicant will fill the seat beginning at the February 9, 2023 Regular District Board Meeting.

#### **Fiscal Effect**:

By filling the Board vacancy by appointment instead of holding a special election, the District is saving at least \$7,500-\$10,000.

#### **Recommendation:**

Staff recommends that the District Board review the application, hear a presentation or statement from the applicant, and appoint the applicant to the vacant District Board seat by adopting Resolution No. 2023-01.

- **WHEREAS,** the Ukiah Valley Sanitation District ("District") district election scheduled for November 8, 2022 was cancelled because only two people filed to run for the three available Board positions and those two persons who filed were automatically appointed pursuant to Elections Code section 10515; and
- **WHEREAS**, the third available Board position resulted in a vacancy which became effective December 2, 2022; and
- **WHEREAS**, Government Code Section 1780 sets forth the procedure for filling Board vacancies and provides that the District Board shall, within 60 days from the commencement of the vacancy, either fill the vacancy by appointment or call a special election to fill the vacancy; and
- **WHEREAS,** at its December 14, 2022 meeting, the Board voted to fill the vacancy by appointment; and
- **WHEREAS**, under Government Code Section 1780(d)(2), when a vacancy occurs in the first half of a term of office and at least 130 days prior to the next general district election, the person appointed holds office until the next general district election; and
- **WHEREAS**, this vacancy occurs in the first half of a term of office and the next general district election is more than 130 days after the effective date of the vacancy; and
- **WHEREAS**, the person appointed to fill the vacancy shall serve until the District's next general district election in November 2024.
- **NOW, THEREFORE,** the Board of Directors of the Ukiah Valley Sanitation District, County of Mendocino, State of California does hereby resolve as follows:
- **SECTION 1.** The Board of Directors finds that the recitals above are true and correct and incorporated into this Resolution by reference.
- **SECTION 2.** The Board of Directors hereby appoints Bradley Best to fill the Board seat vacant as of December 2, 2022.
- **SECTION 3.** The person appointed as set forth in this Resolution shall serve on the District Board until the person who is elected by District voters at the November 5, 2024 general district election has been certified as the successor to serve on the Ukiah Valley Sanitation District Board of Directors.
- **SECTION 4.** This Resolution shall take effect upon adoption, and the City Clerk shall certify to the adoption of this Resolution.
